**WHEREAS**, during this time, Deputy Lenic communicated with the Unified Communication Center and EMS personnel to successfully deliver medics on scene; and

**WHEREAS,** Schenectady County applauds the heroic actions of Sgt. DeCarlo and Deputy Lenic and wishes to highlight the importance of their quick responses and actions, and successful teamwork, which resulted in a life saved; now, therefore be it
