The County of Schenectady has had difficulty filling open positions for employees in the Mechanics series job titles and the Construction/Plow Driver Series job titles.

I am requesting approval of an Amendment to a Collective Bargaining Agreement with the CSEA Local 1000 AFSCME, AFL-CIO, Schenectady County Unit Local 885. The current agreement has a term beginning January 1, 2021, and ending December 31, 2025.

Attached is a memorandum from Christopher Gardner, County Attorney, regarding the proposed amendment. Under this agreement, the titles under Mechanic title Services and Construction-Driver Services will receive a \$3.00 per hour raise beginning on the first pay period of June 2023. In addition, the maximum compensatory time off accrual cap for those titles is reduced from 240 hours to 120 hours. These changes will address staffing shortages at the Department of Public Works.

Attached is a memorandum from Christopher H. Gardner, County Attorney, requesting authorization to create the position of Deputy County Attorney (JC-10) in the Law Department's Department of Social Services Division. Over the years, the attorneys in this division have seen an increase in their workloads as a result of several issues which include, but are not limited to, the intensive work required for the Appellate Division, an increase in older residents that rely on resources from Adult Protective Services, and the relaunch of Family Treatment Court. As Mr. Gardner indicates, these issues, along with the temporary leave of two employees in the division, would be alleviated by the addition of another Deputy Attorney.

The attached memoranda from Jaclyn Falotico, Commissioner of Finance, and Joe McQueen, Director of Human Resources, detail the actions necessary to create the position.

Creation of An Additional Deputy County Attorney Position for Representation

Abuse and Neglect Proceedings

I am requesting the creation of an additional Deputy County Attorney position for representation in Child Abuse and Neglect proceedings at a salary of \$87,612 at the County Attorney's DSS Office at 388 Broadway.

BACKGROUND

There are currently ten (10) attorneys employed in the County Attorneys Office including myself. The current configuration has five (5) attorneys assigned to the DSS Office headed by First Deputy County Attorney Mike Godlewski handling all DSS cases including Child Abuse and Neglect cases. These five (5) attorneys practice primarily in Family Court.

Five (5) attorneys, including myself, work at 620 State Street. Two (2) of the five (5) are assigned to prosecute Juvenile Delinquency (JD) and Persons in Need of Supervision cases in Family Court and Kendra's Law cases in State Supreme Court which involves mandation of drug treatment medication of individuals who without treatment would pose a threat to others and themselves.

This leaves myself and two (2) other attorneys to perform all other legal functions for the County of Schenectady, including labor contract negotiations, disciplinary investigations involving sexual harassment work place violence and other disciplinary issues. Additionally, this office represents the County in all real estate transactions, non-labor contract negotiations and the entire range of County legal issues.

SHORT TERM STAFFING CHALLENGES

First Deputy County Attorney Michael Godlewski is leaving my office in June to take a position in the Office of Court Administration as a Court Referee. Mike did an outstanding job and he will be missed.

I am transferring and promoting Senior Deputy County Attorney Jennifer Barnes to First Deputy County Attorney to head our DSS office. Jennifer has over twenty-five (25) years of Family Law experience and I am confident that she will do an excellent job in the new position. I have also hired Bethany Dixon to backfill Jennifer Barnes' role in JD, PINS and Kendra's Law cases.

At the same time, Mike Godlewski is leaving our 388 Broadway, DSS office, I also have two (2) other Deputy County Attorneys there who have overlapping child rearing leaves scheduled later in the year reducing our staffing at that office from five (5) attorneys to three (3) attorneys for a few months.

I am requesting a new Deputy County Attorney position be created in our DSS office to help us through this short-term staffing shortage in order to overt a crisis, but also to provide long-term stability. The addition of one additional Deputy County Attorney will help meet the legal challenges in our DSS office on a continuing basis and help address burnout and high turnover which is the result of a high caseload.

The First Deputy oversees the day-to-day operation of the office, handling emergency applications, handling complex cases, appeal, Adult Protective Services, and resolution of Medicaid liens. Three (3) attorneys are assigned to each of our three (3) Family Court Judges and a fourth attorney handles Child Support cases before two (2) Support Magistrates, violations of Child Support Petitions before three (3) Family Court Judges and all OCFS hearings before an Administrative Law Judge.

APPEALS

The overall workload is overwhelming even when the office is fully staffed. One critical issue is that the County Attorneys Office handles all appeals to the Appellate Division of the Supreme Court. In contrast, neither the Public Defender nor the Conflict Defender have any role in perfecting appeals. The increasing caseload in Appellate work in and of itself justifies an additional attorney since the Appellate work alone requires one full-time equivalent (FTE). There are also other factors that require an additional attorney.

FAMILY TREATMENT COURT

In 2021, the Office of Court Administration re-launched Family Treatment Court, Judicial Hearing Officer James Doern presiding over Family Treatment Court, which essentially creates a fourth Family Court Judge, which must be staffed by a County Attorney.

ADULT PROTECTIVE SERVICES

The caseload in Adult Protective Services has exploded. In 2015, there were 136 cases in APS. By 2022, this number had more than doubled to 315. These are all County Attorney cases.

CONCLUSION

The increases in the number of Judges, the increases in Appellate volume, the increases in Adult Protective Services cases, and the increased complexity of OFCS Fair Hearings has created a compelling need for a sixth County Attorney in our DSS Office.

I respectfully request that you forward this request to the County Legislature for its consideration at its meeting on May 9, for the creation of a new Deputy County Attorney position at the salary of \$87,612. Thank you for your consideration.
