Call to Order

Designations of Majority Leader and Minority Leader

The Clerk read the certificates filed by the Democratic Caucus designating Legislator Richard Patierne as Majority Leader for the 2024-2025 legislative sessions, and the certificate filed by the Republican Caucus designating Eric Hess as Minority Leader for the 2024-2025 legislative sessions.

Legislator Patierne was then duly sworn in as Majority Leader, with the Oath of Office being administered by Judge Hoffman.

Mr. Patierne made brief inaugural remarks.

Legislator Hess was sworn in as Minority Leader, with the Oath of Office being administered by Yvonne Cleveland.

Mr. Hess made brief inaugural remarks.

Election of Chair

The Clerk opened the floor to nominations for Chair of the Schenectady County Legislature.

Legislator Jasenski rose to nominate Legislator Gary Hughes. Legislator Fields seconded the nomination.

Seeing no other nominations, the Clerk called the roll for the election of Chair of the Legislature.
