Re: Call for a Public Hearing Regarding Proposed Agricultural Districts

Attached is a memorandum from Ray Gillen, Commissioner of Economic Development and Planning, and Stephen Feeney, Planner, requesting a call for a public hearing on four proposed applications, one in the Town of Glenville and three in the Town of Duanesburg.

The sole application in the Town of Glenville involves one 10-acre parcel on which the owner operates a small poultry and egg farm.

The first application in the Town of Duanesburg involves three parcels totaling 59-acres where the Saddlemire Family Farm raises beef cattle, chickens, and hogs. The second application in the town involves one 5-ace parcel where Greentea Properties, LLC grows medicinal herbs. The third application involves two parcels totaling 29.73 acres of land that the owner intends to farm next year.

The County Agricultural and Farmland Protection Board has already reviewed the requests and recommended the lands' inclusion in the County's Agricultural District. Before these can be included, the County Legislature must set a public hearing in accordance with NYS Agricultural and Markets Law.

The County received four applications in 2023 under the annual 30-day review period (which takes place in December) for inclusion in the Schenectady County Agricultural District. There are three applications with property located in the Town of Duanesburg (Jennings, Perry, & Silva) and one application in Glenville (Davila). Attached is a summary report of the parcels from the County Agricultural and Farmland Protection Board.

In Glenville, Christine Davilla owns one 10-acre parcel. She operates a small poultry/egg farm.

In Duanesburg, Gregory and Jacqueline Jennings own three parcels totaling 59 acres where they have beef cattle, chickens, and hogs. (Saddlemire Family Farm). The Perry application includes one 5-acre parcel where he grows medicinal herbs (Greentea Properties, LLC). The Silva application includes two agricultural parcels totaling 29.73 acres of land that is not currently actively farmed. He intends to start farming the property next year.

Attached is a location map for the applications and individual maps of the three properties in question.

The County Agricultural and Farmland Protection Board (AFPB) reviewed the requests and recommended inclusion of the parcels in the County Agricultural District.

In accordance with NYS Agricultural and Markets Law, after receiving the recommendation of the AFPB, the County Legislature must hold a public hearing on the proposed Agricultural District. We are requesting that the Legislature set a public hearing to consider the recommendation from the AFPB to include the four applications (seven parcels) in the district.

Below is a chart showing the parcels associated with the four applications received in 2023 under the annual 30-day review period for inclusion in the Schenectady County Agricultural District.







NOW, THEREFORE, the parties hereby agree as follows:

- 1. The Bargaining Unit: This Agreement shall cover All full-time and part-time employees of Schenectady County in the following classifications: Assistant Public Defender I, Assistant Public Defender II, Assistant Public Defender III, Assistant Public Defender IV, Assistant Public Defender V, Chief Assistant Public Defender and all other law graduates and attorneys in the Department of Public Defender excluding the Public Defender ("Bargaining Unit").
- 2. The parties acknowledge that a majority of workers in the Bargaining Unit have chosen the Union as their exclusive representative.
- Schenectady County recognizes the Union as the exclusive representative of the employees in the Bargaining Unit pursuant to Section §204 of the Public Employees' Fair Employment Act ("Taylor Law") effective upon the execution of this Agreement.
- 4. Schenectady County agrees to meet and bargain with the Union for the purpose of negotiating a collective bargaining agreement that establishes wages, benefits and other terms and conditions of employment for the Employees in the Bargaining Unit.

#### **Purpose and General Idea:**

Provides Authorization to Enter into a Multi-Year Agreement with the NYS Office of Children and Family Services.

#### **Summary of Specific Provisions:**

Authorizes the acceptance of \$354,640 in funding from the NYS Office of Children and Family Services This is a multi-year agreement with the NYS Office of Children and Family Services with a term starting February 1, 2024 and ending January 31, 2029. \$5,928 of these funds will be used to provide training to the team, educational outreach materials, and supplies. The remaining funds will support the creation of the Child Advocacy Center Education and Support Specialist position. This new position will be tasked with providing direct services to child victims and their non-offending caregivers, participating with the Child Fatality Review Team in identifying risk factors for child abuse and fatality, and working on developing outreach programs for schools and our healthcare agencies.

#### **Effects Upon Present Law:**

The Department of Finance provides the following amendment to the 2024 Operating Budget to accommodate new multi-year funding from New York State Office of Children and Family Services for the Child Fatality Review Team (CFRT) and support the creation of a new position of Education and Support Specialist within the Child Advocacy Center at an annual salary of \$65,000.

As part of that agreement, the County is awarded \$354,640 which will be used to support the Child Fatality Review Team. Of that amount, \$5,928 will be used annually for training the team, educational outreach materials, and supplies. As Mr. Carney indicates, this new position will be tasked with providing direct services to child victims and their non-offending caregiver, participate with the Child Fatality Review team in identifying risk factors for child abuse and fatality, and work on developing outreach programs for schools and health care agencies.

The attached memoranda from Jaclyn Falotico, Commissioner of Finance, and Joe McQueen, Director of Human Resources, detail the actions necessary to create the position.

I am pleased to inform you that we are in receipt of two new grants to support the work of our Child Advocacy Center (hereafter CAC). Under the management of Director Susan Casey, the staff at the CAC continue to impress funding authorities with the professionalism of their work on behalf of victimized children and consequently are awarded additional resources to support their mission.

#### Standalone OCFS Supplemental Grant

Attached is an award letter from the NYS Office of Children and Family Services dated February 27, 2024, advising us of an award of \$49,999, to be spent within a challenging timeline of between March 1, 2024 and September 30, 2024. Funds must be used to supplement and not supplant existing resources. Permitted uses include: staffing, equipment, supplies, occupancy costs and training. Because this is a one shot grant, we do not want to use it to add staff that would be paid for only through September and thereafter encumber county resources.

We have identified three needs that this grant can provide for us. We would like to purchase two licenses for software titled Social Links CrimeWall Pro. SL CrimeWall is an Open Source Intelligence investigative platform designed to simplify the entire intelligence cycle, from data extraction, through visualization, processing and compilation of information gleaned from over 500 open sources, including social media, messengers, blockchains, and the dark web. Our MDT Case Coordinator, Julia Reyes, came to us after having experience as a cybercrime analyst for the National Center for Missing and Exploited children. She is experienced using this type of search engine, as is our financial crime analyst Justin Colarossi who would receive the other license. Together using these licenses, they can assist in the investigation of the increasing numbers of cases seen at the CAC involving child sexual abuse involving CSAM (Child Sexual Abuse Materials). A case management feature allows licensed analysts to seamlessly collaborate on the same project boards, monitor and track subject developments, and jointly create final reports. Recently my Special Victims Bureau Chief John Carson obtained a verdict in County Court convicting a 40-year old career criminal of statutory rape of a 13-year old child and crimes involving the creation and possession of images and videos of his child victim using social media. This tool would benefit many child sexual abuse investigations that come through the CAC, and the work of our in-house analysts will support the work of our detectives throughout the county collaboratively on these cases. The cost of these two licenses is \$16,000.

For the second need, we propose collaborating with the Schenectady Police Department to purchase the MVAC data collection system. This is a sophisticated DNA collection tool that captures exponentially more DNA material than other methods, leading to improved investigation and greater prosecution of child abuse cases. It will be available for use by all of our partner agencies within the Multi-Disciplinary Teams. The total cost of this equipment is approximately \$43,000. We propose spending \$20,000 of this grant toward the cost of this device, the rest to be paid by the police department.

The third need we have identified is expansion of the CAC facility at 388 Broadway. Working with Facilities we have identified space that is currently underutilized that abuts our current location. We would like to expand the CAC footprint to create an office for the Mental Health Clinician that is more soundproof than the current location, an office for a CPS caseworker, an office for a detective, a storage closet, and a larger office for collaboration by the team in abuse cases. The goal is to have a facility at which a special abuse team could be truly co-located. The balance of this grant, \$13,999, as well as the balance of funding from the grant recently obtained by Assemblyman Steck, should pay for the construction and furnishing of this space.

#### Child Fatality Review Team (CFRT)

The second grant is also from OCFS, in the amount of \$354,640 spread out over five years, for \$70,928 per year. This funding likewise cannot supplant existing funding streams, but because it is guaranteed for five years, it is appropriate to use it to increase staffing. The award letter for this grant is also attached. With this money we propose the creation of a position titled "Child Advocacy Center Education and Support Specialist." We believe that the creation of this position will strengthen the professional practices and policies of the CAC and permit us to fulfill the expectations placed on us in embarking on the Child Fatality Review process. The Education Specialist will participate with the review team in identifying risk factors for child abuse and fatality and work on developing outreach programs for schools and health care agencies. By focusing on public education and outreach, the goal is to reduce and prevent child abuse and fatality.

The specialist will also be tasked with providing direct services to child victims and to their non-offending caregivers, consisting of advocacy, service planning, and delivery. Currently we do not provide victim advocacy on a full-time basis by an advocate co-located at the CAC, so this position will fill a gap in our current program and permit us to more closely adhere to the national standards required of CAC's regarding victim advocacy.

We envision the Education Specialist to be a management position who will function as part of the management team at the CAC along with the Director and Assistant Director. We would like to attract someone with a master's degree to this position and as such are asking for an amendment of the District Attorney's Operating budget to create this position at a salary of \$65,000.

The balance of the grant, or \$5,928 per annum for five years will be budgeted for training for the Child Fatality Review team and procedures, educational outreach materials, and supplies.

I am pleased to inform you that we are in receipt of two new grants to support the work of our Child Advocacy Center (hereafter CAC). Under the management of Director Susan Casey, the staff at the CAC continue to impress funding authorities with the professionalism of their work on behalf of victimized children and consequently are awarded additional resources to support their mission.

#### Standalone OCFS Supplemental Grant

Attached is an award letter from the NYS Office of Children and Family Services dated February 27, 2024, advising us of an award of \$49,999, to be spent within a challenging timeline of between March 1, 2024 and September 30, 2024. Funds must be used to supplement and not supplant existing resources. Permitted uses include: staffing, equipment, supplies, occupancy costs and training. Because this is a one shot grant, we do not want to use it to add staff that would be paid for only through September and thereafter encumber county resources.

We have identified three needs that this grant can provide for us. We would like to purchase two licenses for software titled Social Links CrimeWall Pro. SL CrimeWall is an Open Source Intelligence investigative platform designed to simplify the entire intelligence cycle, from data extraction, through visualization, processing and compilation of information gleaned from over 500 open sources, including social media, messengers, blockchains, and the dark web. Our MDT Case Coordinator, Julia Reyes, came to us after having experience as a cybercrime analyst for the National Center for Missing and Exploited children. She is experienced using this type of search engine, as is our financial crime analyst Justin Colarossi who would receive the other license. Together using these licenses, they can assist in the investigation of the increasing numbers of cases seen at the CAC involving child sexual abuse involving CSAM (Child Sexual Abuse Materials). A case management feature allows licensed analysts to seamlessly collaborate on the same project boards, monitor and track subject developments, and jointly create final reports. Recently my Special Victims Bureau Chief John Carson obtained a verdict in County Court convicting a 40-year old career criminal of statutory rape of a 13-year old child and crimes involving the creation and possession of images and videos of his child victim using social media. This tool would benefit many child sexual abuse investigations that come through the CAC, and the work of our in-house analysts will support the work of our detectives throughout the county collaboratively on these cases. The cost of these two licenses is \$16,000.

For the second need, we propose collaborating with the Schenectady Police Department to purchase the MVAC data collection system. This is a sophisticated DNA collection tool that captures exponentially more DNA material than other methods, leading to improved investigation and greater prosecution of child abuse cases. It will be available for use by all of our partner agencies within the Multi-Disciplinary Teams. The total cost of this equipment is approximately \$43,000. We propose spending \$20,000 of this grant toward the cost of this device, the rest to be paid by the police department.

The third need we have identified is expansion of the CAC facility at 388 Broadway. Working with Facilities we have identified space that is currently underutilized that abuts our current location. We would like to expand the CAC footprint to create an office for the Mental Health Clinician that is more soundproof than the current location, an office for a CPS caseworker, an office for a detective, a storage closet, and a larger office for collaboration by the team in abuse cases. The goal is to have a facility at which a special abuse team could be truly co-located. The balance of this grant, \$13,999, as well as the balance of funding from the grant recently obtained by Assemblyman Steck, should pay for the construction and furnishing of this space.
