WHEREAS, to this day the rights of LGBTQ+ Americans are under attack and members of the LGBTQ+ community — especially people of color and trans people — continue to face discrimination and cruel, persistent efforts to undermine their human rights; and

WHEREAS, each June we reflect on the progress we have made as a community, state and nation in the fight for justice, inclusion, and equality while reaffirming our commitment to do more to support LGBTQ+ rights; and

#### **RESOLUTION 82-24**

#### A RESOLUTION AUTHORIZING THE COUNTY MANAGER TO ENTER INTO AN AGREEMENT FOR THE OPTION TO PURCHASE IMPROVEMENTS, A GROUND LEASE, AND THE PURCHASE OF PROPERTY

**BE IT ENACTED** by the Legislature of the County of Schenectady, as follows:

WHEREAS, the Schenectady County Attorney by memorandum dated May 9, 2024 recommends that Schenectady County enter into an option agreement with 1 Broadway Tower, LLC for the option to purchase a building and land of certain real estate located adjacent to State Street in the City of Schenectady (One Broadway Center – in downtown Schenectady behind Proctors – the former "Lottery Building"); and

WHEREAS, the Schenectady County Attorney advises that 1 Broadway Center, LLC has agreed to an option price of \$75,000.00, with the effective date of the option being May 15, 2024, and the last date to execute the option being August 15, 2024; and

WHEREAS, the County Attorney further advises that the option, if executed, is for three months (with the possibility of a one-month extender for an additional expense of \$75,000.00) so that the County can perform its due diligence regarding the sale of the building and land; and

WHEREAS, the County Attorney further advises that, if the County opts to purchase the building, the closing must take place within thirty days after the option period or extension; and

WHEREAS, the County Attorney further advises that the purchase price of the building is \$6,000,000.00, and upon closing of the building, the ground lease commences at an annual rent of \$500,000.00 (triple net); and

WHEREAS, the County Attorney further advises that the County has the option to purchase the land at a cost of \$6,000,000.00, but such purchase can be no earlier than April 1, 2025 and no later than April 30, 2025; and

WHEREAS, the County Attorney further advises that, if the County purchases the land and building, it will assume the remaining rents of the outstanding lease with the U.S. Social Security Administration (which could amount to a total of approximately \$2.79 million), and the outstanding radio tower leases (which could amount to a total of approximately \$500 thousand); and

WHEREAS, the Schenectady County Manager by memorandum dated May 10, 2024 recommends that Schenectady County enter into an option agreement with 1 Broadway Tower, LLC for the option to purchase the aforesaid building and land for the amounts indicated above, and that appropriate budgetary amendments be approved; now, therefore, be it

**RESOLVED**, that the Schenectady County Manager be and he hereby is authorized, after approval of the County Attorney as to form and content, to enter into an Agreement for the Option to Purchase Improvements, Ground Lease, and Purchase of Real Property with 1 Broadway Tower, LLC for the option to purchase the aforesaid building and land for the amounts indicated above; and, be it further

## A RESOLUTION APPROVING THE SCHENECTADY COUNTY INVESTMENT POLICY

**BE IT ENACTED,** by the Legislature of the County of Schenectady, as follows:

WHEREAS, section 39 of the NYS General Municipal Law provides that Schenectady County shall, by resolution, adopt a comprehensive investment policy that details the County's operative policy and instructions to officers and staff regarding the investing, monitoring, and reporting of funds of such County; and

WHEREAS, the Commissioner of Finance by memorandum dated May 3, 2024 advises that the Department of Finance has developed a comprehensive investment policy to establish the Department's operations and instructions for investing, monitoring, and reporting of the County's funds, and such Policy was filed with the Clerk of the Legislature on May 14, 2024; and

WHEREAS, the Commissioner of Finance recommends that this Governing Body adopt the aforesaid Schenectady County Investment Policy; and

WHEREAS, the County Manager by memorandum date May 10, 2024 recommends that this Governing Body adopt the aforesaid Schenectady County Investment Policy; now, therefore, be it

**RESOLVED,** that the Schenectady County Investment Policy, annexed hereto and made a part hereto, be and it hereby is approved and adopted.

#### SCHENECTADY COUNTY INVESTMENT POLICY

#### I. Scope

This investment policy applies to all monies and other financial resources available to Schenectady County for deposit and investment by Schenectady County on its own behalf.

Except for cash in certain restricted and special funds, Schenectady County will aim to consolidate cash balances from all funds to maximize potential investment earnings. Investment income will be allocated to the various funds based upon their proportional participation and in accordance with generally accepted accounting principles.

#### II. Objectives

Schenectady County's investment policy and investment activities shall conform to all applicable federal, state, and other legal requirements. The primary objectives of Schenectady County's investment activities are, in priority order:

- To adequately safeguard principal:
  - Preservation of principal is a critical objective of the Schenectady County Investment Policy. Investments shall be undertaken in a manner consistent with preserving capital and mitigating both credit risk and interest rate risk;
- To provide sufficient liquidity to meet all operating requirements:
  - Schenectady County's investment portfolio shall remain sufficiently liquid to meet all operational requirements that may be reasonably anticipated; and
- To obtain a reasonable rate of return:
  - O Schenectady County's investment portfolio shall be designed with the objective of attaining a market rate of return throughout budgetary and economic cycles, taking into consideration investment risks and liquidity needs as forecasted by the County's cash flow models and analysis. Return on investment is of secondary importance compared to the safety and liquidity objectives referenced above.

#### **III.** Delegation of Authority

The Schenectady County Legislature's responsibility for administration of the investment program is delegated to the Commissioner of Finance who shall establish written procedures for the operation of the investment program consistent with these investment policies. Such procedures shall include internal controls to provide a satisfactory level of accountability based upon records incorporating the description and amounts of investments, the fund(s) for which they are held, the place(s) where kept, and other relevant information, including dates of sale or other dispositions and amounts realized. In addition, the internal control procedures shall describe the responsibilities and levels of authority for key individuals involved in the investment program.

#### IV. Prudence

Participants in the investment process shall seek to act responsibly as custodians of the public trust and shall avoid any transaction that might impair public confidence in the County to govern effectively.

Investments shall be made with prudence, diligence, skill, judgement and care, under circumstances then prevailing, which knowledgeable and prudent persons acting in like capacity would use, not for speculation, but for investment, considering the safety of the principal as well as the probable income to be derived.

Participants involved in the investment process shall refrain from personal business activity that could conflict with proper execution of the investment program or which could impair their ability to make impartial investment decisions.

#### V. Diversification

It is the policy of Schenectady County to diversify its deposits and investments by financial institution, by investment instrument, and by maturity scheduling.

#### VI. Internal Controls

It is the policy of Schenectady County for monies collected by any officer or employee of the government to immediately transfer those funds to the Commissioner of Finance.

The Commissioner of Finance is responsible for establishing and maintaining internal control procedures to provide reasonable, but not absolute, assurance that deposits and investments are safeguarded against loss from unauthorized use or disposition, that transactions are executed in accordance with management's authorization, properly recorded, and managed in compliance with applicable laws and regulations.

#### VII. Designation of Depositories

The banks and trust companies that are authorized for the deposit of money are as follows:

KeyBank Bank of America JP Morgan Chase

#### VIII. Securing Deposits and Investments

Deposits and investments at a bank or trust company, including demand deposits, certificates of deposit and special time deposits (hereinafter, collectively, "deposits") made by officers of Schenectady County that are in excess of the amount insured under the provisions of the Federal Deposit Insurance Act, including pursuant to a Deposit Placement Program in accordance with law, shall be secured by a method of collateralization in compliance with GML Section 10(3)(a).

#### IX. Collateralization and Safekeeping

Eligible securities used for collateralizing deposits made by officers of Schenectady County shall be subject to bank security and custodial agreements.

The security agreement shall provide that eligible securities (or the pro rata portion of a pool of eligible securities) are pledged to secure such deposits together with agreed-upon interest, if any, and any costs or expenses arising out of the collection of such deposits upon a default. It shall also provide the conditions under which the securities (or pro rata portion of a pool of eligible securities) held may be sold, presented for payment, substituted or released and the events of default which will enable the local government to exercise its rights against the pledged securities.

In the event that the pledged securities are not registered or inscribed in the name of Schenectady County, such securities shall be delivered in a form suitable for transfer or with an assignment in blank to Schenectady County or the custodial bank or trust company. Whenever eligible securities delivered to the custodial bank or trust company are transferred by entries on the books of a federal reserve bank or other book-entry system operated by a federally regulated entity without physical delivery of the evidence of the obligations, then the records of the custodial bank or trust company shall be required to show, at all times, the interest of the local government in the securities (or the pro rata portion of a pool of eligible securities) as set forth in the security agreement.

The custodial agreement shall provide that pledged securities (or the pro rata portion of a pool of eligible securities) will be held by the custodial bank or trust company as agent of, and custodian for Schenectady County, will be kept separate and apart from the general assets of the custodial bank or trust company and will not be commingled with or become part of the backing of any other deposit or other bank liability. The agreement shall also describe how the custodian shall confirm the receipt, substitution or release of the collateral and it shall provide for the frequency of revaluation of collateral by the custodial bank or trust company and for the substitution of collateral when a change in the rating of a security causes ineligibility. The security and custodial agreements shall also include other provisions necessary to provide Schenectady County with a perfected security interest in the eligible securities and to otherwise secure the local government's interest in the collateral and may contain other provisions that the governing board deems necessary.

#### X. Permitted Investments

As provided by General Municipal Law Section 11, Schenectady County authorizes the Commissioner of Finance, or officer having custody of funds to invest monies not required for immediate expenditure, for terms not to exceed its projected cash flow needs in the following types of investments:

- Obligations issued, or fully insured or guaranteed, as to the payment of principal and interest, by the United States of America, an agency thereof or a United States government sponsored corporation.

 Obligations issued or fully insured or guaranteed by the State of New York, obligations issued by a municipal corporation, school district or district corporation of such State or obligations of any public benefit corporation which under a specific State statute may be accepted as security for deposit of public monies.

Any obligation that provides for the adjustment of its interest rate on set dates is deemed to be payable or redeemable on the date on which the principal amount can be recovered through demand by the holder.

#### **XI.** Purchase of Investments

The Commissioner of Finance is authorized to contract for the purchase of investments:

- 1. Directly, from an authorized trading partner.
- 2. By participation in a cooperative investment agreement with other authorized municipal corporations pursuant to Article 5-G of the General Municipal Law and in accordance with Article 3-A of the General Municipal Law.

Purchased obligations, unless registered or inscribed in the name of the local government, shall be purchased through, delivered to, and held in the custody of a bank or trust company. Such obligations shall be purchased, sold, or presented for redemption or payment by such bank or trust company only in accordance with prior written authorization from the officer authorized to make the investment. All such transactions shall be confirmed in writing to Schenectady County by the bank or trust company.

Any obligation held in the custody of a bank or trust company shall be held pursuant to a written custodial agreement as described in General Municipal Law Section 10(3)(a). The agreement shall provide that securities held by the bank or trust company as agent of, and custodian for, Schenectady County will be kept separate and apart from the general assets of the custodial bank or trust company and will not be commingled with or become part of the backing of any other deposit or other bank liability. The agreement shall also describe how the custodian shall confirm the receipt and release of the securities. Such agreement shall include provisions necessary to secure the local government's perfected interest in the securities, and the agreement may also contain other provisions that the governing board deems necessary. The security and custodial agreements shall also include other provisions necessary to provide Schenectady County with a perfected interest in the securities.

The Commissioner of Finance, where authorized, can direct the bank or trust company to register and hold the evidence of investments in the name of its nominee, or may deposit or authorize the bank or trust company to deposit, or arrange for the deposit of any such evidence of investments with a federal reserve bank or other book-entry transfer system operated by a federally regulated entity. The records of the bank or trust company shall show, at all times, the ownership of such evidence of investments, and shall, when held in the possession of the bank or trust company be kept separate from the assets of the bank or trust company. Evidence of investments delivered to

a bank or trust company shall be held by the bank or trust company pursuant to a written custodial agreement as set for in General Municipal Law Section 10(3)(a), and as described earlier in this section. When any such evidences of investments are so registered in the name of a nominee, the bank or trust company shall be absolutely liable for any loss occasioned by the acts of such nominee with respect to such evidences of investments.

#### **XII.** Annual Review and Amendments

Schenectady County shall review this investment policy annually, and it shall have the power to amend this policy at any time.

It is declared to be the intent and purpose of this law to enable the County of Schenectady to have the general care and control of the corporate real and personal property of the County in order to benefit the inhabitants thereof in accordance with the New York State County Law.

Section 2: Notwithstanding the provisions of section two hundred fifteen of the County Law or any other provision of law to the contrary, this Legislature hereby determines that County real property in the City of Schenectady as hereinafter described is no longer necessary for use by the County and that all the right, title and interest of the County in such real property shall be conveyed to TigerBridge Property Group, LLC without public advertisement or competitive bidding.

Section 3: The parcel of real property situated in the City of Schenectady (519 State Street) and County of Schenectady, State of New York, subject to this Local Law are described as follows:

S/B/L: 39.80-1-28.1.

Section 4: The Legislature shall, by duly adopted resolution or by contract or by instruments authorized by such resolution, convey, for the consideration of one hundred sixty-two thousand and five hundred (\$162,500.00) dollars, the real property, or a portion thereof, hereinbefore described for use by TigerBridge Property Group, LLC.

**BE IT ENACTED,** by the Legislature of the County of Schenectady, as follows:

WHEREAS, the County Attorney by memorandum dated May 9, 2024 recommends that Schenectady County enter into a preliminary agreement with SUNY Schenectady and Adirondack Aquatic Center (a not-for profit corporation) regarding the operation and construction of an Aquatic Center on land owned by Schenectady County; and

WHEREAS, the County Attorney advises that the proposed Aquatic Center will be 80,000+/- square feet that will be constructed on County-owned land that is adjacent to the SUNY Schenectady dormitory; and

WHEREAS, the County Attorney further advises that the most recent estimate for the construction of the Aquatic Center is \$41,731,551.00; and

WHEREAS, the County Attorney further advises that there are three primary sources for funding of this project:

- 1. The State University of New York provides fifty percent (50%) of funding of the cost of SUNY Schenectady construction projects;
- 2. The Adirondack Aquatic Center has raised \$21.5 million for this project; and

3. Schenectady County will provide \$5 million, and any other additional funds necessary for the final fifty percent match; and

WHEREAS, the County Attorney further advises that the County will be responsible for the construction of the Aquatic Center, including all phases of design architecture and engineering after consultation and agreement with SUNY Schenectady and the Adirondack Aquatic Center; and

WHEREAS, the County Attorney further advises that upon completion of construction of the Aquatic Center the County will own the facility in trust for SUNY Schenectady; and

WHEREAS, the County Attorney further advises that the Aquatic Center will be operated by Adirondack Aquatic Center for an initial twenty-year term; and

WHEREAS, the County Attorney further advises that a newly created Aquatic Center Oversight Advisory Board comprised of seven members will have general oversight authority over the operation of the Aquatic Center; and

WHEREAS, the County Manager by memorandum dated May 10, 2024 recommends that Schenectady County enter into the aforesaid Preliminary Agreement for the operation and construction of an Aquatic Center on land owned by Schenectady County; now, therefore be it

**RESOLVED**, that the County Manager be and he hereby is authorized, after approval of the County Attorney as to form and content, to negotiate and to execute a Preliminary Agreement with SUNY Schenectady and Adirondack Aquatic Center consistent with the provisions of this Resolution.

WHEREAS, Schenectady County values diversity and is committed to promoting inclusiveness and understanding among all cultures and religions; now, therefore be it
