Schenectady County Soil & Water Conservation District Board of Directors Meeting Minutes May 22, 2024

Present: Steven Ruther, Michael Pileggi, B. Donald Ackerman, Eric Hess, Nicholas Klemczak, Joe Braun

The meeting was **called to order** 10:00 am by Steven Ruther, Chairperson.

Privilege of the Floor: none

Steven Ruther asked for a <u>motion to approve</u> the February Meeting Minutes. Motion to approve made by Donald Ackerman seconded by Eric Hess. Motion carried.

Financial

The **Treasurer's Report** was reviewed. Steven Ruther asked for a motion to approve the report. Eric Hess motioned to approve, seconded by Donald Ackerman. Motion carried.

The **Paid Bills Report** was reviewed. A question was raised regarding the Ewaste payment. Nicholas explained it was the January 2023-April 2024 bill which included services for fluorescent bulbs and battery recycling.

Steven Ruther asked for a motion to approve the report. Motioned by Donald Ackerman, seconded by Eric Hess. Motion carried.

2025 Budget Adoption

Nicholas summarized the 2023 Final Budget and noted that compost revenue was up for the year.

After, he reviewed the proposed 2025 Budget, pointing out the yellow highlighted items indicate increase, green highlighted areas indicate decrease on the spreadsheet.

The <u>Compost Budget</u> was reviewed first, showing major expenses such as product purchases, equipment repairs, salaries and benefits. Additionally noting that fewer permits may be sold because permits are not required to recycle electronics at the facility. He anticipates yardwaste tipping should remain the same; increases in compost, topsoil and natural wood chip mulch sales; colored wood chip mulch will be kept in stock.

He next reviewed the <u>District Budget</u> explaining: benefit funds; insurance payments for Directors and facility; project budget adjustments; materials/maintenance costs; tree & shrub program expenses; annual flower program; tree planting projects; travel and training; special projects; performance measures funds.

He discussed <u>preserve/bike/hike</u> maintenance expenses and the time involved. He proposed hiring a full-time preserve/bike/hike person to maintain, expand and update with improvements keeping them beautiful for all to use and enjoy. The person could be a "trails coordinator" funded through the District reimbursable by the County. He asked the Directors to consider his proposal to be further discussed at the June Meeting.

Steven Ruther asked for a motion to adopt the 2025 Budget. Michael Pileggi motioned, seconded by Eric Hess. Motion carried.

2024-3 AEM Tier 4 Cost-Share Track Project: 093-0128 Grassed Waterway

Joe and Nick explained Tier 4 funding, available for two years, and where the funds will be appropriated. There are two farms Joe is working with, one project backed out, leaving extra monies available to apply to the remaining project or for a new project. Discussion ensued. Additional projects to be determined.

2024-4 Authorization to send Greenhouse and 2002 Pickup truck to public auction
