A PROCLAMATION CELEBRATING JUNETEENTH 2024, COMMEMORATING THE END OF SLAVERY

WHEREAS, Juneteenth is the oldest known celebration which commemorates the end of slavery in the United States and is a holiday that is spreading throughout our nation; and

WHEREAS, the Juneteenth Celebration honors the history, progress and perseverance of the African-American people and is a time for reassurance, hope and celebration of history and culture; and

WHEREAS, Juneteenth, or June 19, 1865, is considered the date when the last slaves in America were freed, after Gordon Granger, a Union general, arrived in Galveston, Texas to inform enslaved Americans of their freedom and that the Civil War had ended; and

WHEREAS, this put into effect the Emancipation Proclamation, which had been issued more than two and a half years prior, on January 1, 1863, by President Abraham Lincoln; and

WHEREAS, 2024 marks 159 years of freedom celebrations and this day is also sometimes referred to as "Juneteenth Independence Day," "Freedom Day" or "Emancipation Day,"; and

WHEREAS, On June 21st and 22nd the Hamilton Hill Arts Center, which serves nearly 10,000 people throughout Schenectady County and the Capital Region and whose mission is to promote the knowledge, preservation and continued development of African and African American arts and culture, will host its 24th Annual Juneteenth Celebration in Vale Cemetery and at Schenectady's Central Park; now, therefore be it

RESOLVED, that the Schenectady County Legislature recognizes June 19, 2024, as Juneteenth; and therefore, be it further

RESOLVED, that the Schenectady County Legislature hereby honors the significance of the Juneteenth celebration and the achievements and contributions of African Americans, both within our community and across our Nation, and encourages all the citizens of Schenectady to participate in its activities.

WHEREAS, the Director of the Bureau of Engineering further advises that the total cost of the real property purchases is \$ 1,067.00, and the square footage and cost for each parcel is as follows:

- 1. 1736 Washout Road -- \$377.00 for approximately 953 square feet;
- 2. 1197 Sanders Road -- \$320.00 for approximately 777 square feet; and
- 3. 1200 Sanders Road -- \$370.00 for approximately 2,233 square feet; and

WHEREAS, the Director of the Bureau of Engineering further advises that the County needs to be granted temporary easements (for a term of one year) from the owners of each of the aforesaid real properties during the construction of the aforesaid Project; and

WHEREAS, the Director of the Bureau of Engineering further advises that the County would be providing the owners of 1736 Washout Road with a 0.03 acre strip of land along Washout Road, which is necessary for continued compliance with the Town of Glenville zoning regulations; and

WHEREAS, the Director of the Bureau of Engineering further advises that the costs for the purchases of the aforesaid rights-of-way are one hundred percent reimbursable by the NYS Department of Transportation; and

WHEREAS, the County Manager by memorandum dated May 31, 2024 recommends that Schenectady County enter into a Right-of-Way Acquisition Agreement with each of the owners of the three aforesaid real properties for the advancement of the Sanders Road Culvert Replacement Project; now, therefore, be it

RESOLVED, that the County Manager be and he hereby is authorized, after approval of the County Attorney as to form and content, to negotiate and to execute an Agreement to Purchase Real Property with each of the owners of the aforesaid real properties for the acquisition of additional right-of-way by the County from each of the owners, for the granting of temporary easements to the County by each of the owners, and for the abandonment of real property by the County to the owner of 1736 Washout Road, and to execute any and all documents necessary for the conveyance and/or acceptance of the aforesaid real properties by the County consistent with the provisions of this Resolution; and, be it further
