



Schenectady County Community College is located in downtown Schenectady at the corner of State Street (Route 5) and Washington Avenue. (78 Washington Avenue)

Directions

From Route 5, turn onto Washington Avenue. Turn right into the parking lot.

From I 890-

From the west, take Exit 4B-Erie Blvd. Stay to the left and follow ramp "*To Route 5, Scotia.*" Turn left onto Route 5. Just as you enter bridge, take exit ramp on the right. At stop sign turn right, then left into the main parking lot.

From the East, take Exit 4C- "*To Route 5, Scotia.*" Turn left onto Route 5, just as you enter bridge take exit ramp on the right. At stop sign turn right, then left into the main parking lot.

The Stockade Building is a one-story building to the left of the main entrance of the college from the parking lot. A sign/map is located near the walkway.

Guests are welcome; however, room capacity may restrict their attendance.
