#### **A RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A RESERVE FUND FOR THE PAYMENT OF BONDED INDEBTEDNESS**

**BE IT ENACTED**, by the Legislature of the County of Schenectady, as follows:

**WHEREAS**, the Commissioner of the Department of Finance by memorandum dated December 5, 2024 requests that a reserve fund be established from previous capital budget unspent appropriations; and

**WHEREAS**, the Commissioner of the Department of Finance advises that the reserve fund would be used for payment of obligations of capital improvements or equipment purchases of the County; and

**WHEREAS**, the Schenectady County Manager by memorandum dated December 13, 2024 recommends the establishment of the aforesaid reserve fund; now, therefore, be it

**RESOLVED**, that pursuant to section 6-h of the General Municipal Law as amended, there is hereby established a reserve fund to be known as the “Reserve Fund for Payment of Bonded Indebtedness” (hereinafter “Reserve Fund”). The purpose of this Reserve Fund is to accumulate monies for the payment of interest on and principal of indebtedness of one or of several issues of bonds of Schenectady County or the purchase of the same. The Reserve Fund shall not be established for, or monies therein used to pay, any obligations payable in the first instance from assessments, or from taxes levied upon an area in Schenectady County smaller than the area of such County; and, be it further

**RESOLVED**, that the Commissioner of Finance is hereby directed to deposit and secure the monies of this Reserve Fund in the manner provided by section 10 of the General Municipal Law. The Commissioner of Finance may invest the monies in the Reserve Fund in the manner provided by section 11 of the General Municipal Law and consistent with the investment policies of Schenectady County. Any interest earned or capital gains realized on the monies so deposited or invested shall accrue to and become part of the Reserve Fund. The Commissioner of Finance shall account for the Reserve Fund in a manner that maintains the separate identity of the Reserve Fund, whether its assets consist of cash or investment or both, and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investments of the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to this Governing Body a detailed report of the operation and condition of the Reserve Fund; and, be it further

**RESOLVED**, that except as otherwise provided by law, expenditures from this Reserve Fund shall be made only for the purposes for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund without the approval of this Governing Body and without such additional actions or proceedings as may be required by section 6-h of the General Municipal Law and any other law.
