The County received two applications in 2024 under the annual 30-day review period (which takes place in December) for inclusion in the Schenectady County Agricultural District. Both properties are in the Town of Glenville. Attached is a summary report of the parcels from the County Agricultural and Farmland Protection Board.

The Vitus application involves one parcel totaling six acres where the applicant intends to operate a truck farm growing potatoes and vegetables. The Fagan application involves one 25-acre parcel where the current use is poultry (egg production). Plans are to start a fruit tree orchard and grow additional agricultural commodities. Plans are to rehabilitate some of the existing farm structures that date back to 1803.


Attached is a map showing both parcels and aerial photos of the two properties in question.

The County Agricultural and Farmland Protection Board (AFPB) reviewed the requests and unanimously recommended inclusion of the parcels in the County Agricultural District.

In accordance with NYS Agricultural and Markets Law, after receiving the recommendation of the AFPB, the County Legislature must hold a public hearing on the proposed changes to the Agricultural District. We are requesting that the Legislature set a public hearing to consider the recommendation from the AFPB to include the two applications (two parcels) in the district.

Below is a chart showing the parcels associated with the two applications received in 2024 under the annual 30-day review period for inclusion in the Schenectady County Agricultural District.

Both applications involve property in the Town of Glenville. The Vitus application involves one parcel totaling 6 acres where he intends to operate a truck farm, growing potatoes, and vegetables. The Fagan application involves one 25-acre parcel where the current use is poultry (egg production). Plans are to start a fruit tree orchard and grow additional agricultural commodities. Plans are to rehabilitate some of the existing farm structures that date back to 1803. Apparently, the property is one of the last remaining examples of broom corn farms in Schenectady County.

Thank you for your participation in the New York State Department of Health's ongoing Local Health Department (LHD) Performance Incentive Program. In year tweive (2024) of the program, which began in December 2023 and concluded in August 2024, the Department focused on preventing chronic disease via the promotion of physical activity.

The Department is pleased to announce that once again county participation in the program was strong. This year, 46 LHDs receive an award.

Schenectady County participated, receiving a composite score of 5 and has been awarded a total of \$23,286.00. Congratulations.

As with prior Performance Incentive program years, awards must be used to support costs associated with Article 6 eligible services. While costs associated with any eligible activity are acceptable, LHDs are encouraged to consider utilizing the award funds in support of chronic disease prevention activities to promote the implementation of active community strategies to municipalities with Article 6 dollars. Please note that LHDs cannot pay or provide for supplies, materials, or the labor. Below are some examples of funding suggestions that can be promoted.

- Quick-Build/Pop-Up/Demonstration Projects
- Painted bike lanes, sharrows, and crosswalks
- Road, crosswalk, trail, wayfinding signage
- Planters, landscaping/other non-capital pedestrian barriers
- Conceptual/Planning/Computer-alded designs (LHDs should consult the guidance to determine if these are eligible for reimbursement or can only be promoted.)
- Bus shelters/landings, bike racks/cages/fix-it stations, etc.

The Article 6 Team is requesting that each LHD submit a separate voucher for the Performance Incentive award specified in this letter. However, LHDs are not required to voucher the full award amount in a single voucher and may claim award funds throughout the 2025 program (calendar) year, allowing each LHD to determine the timing of the Performance Incentive award payment(s). The Performance Incentive award amount must be reflected on the Performance Incentive line in the 2025 Quarterly Expenditure Report (QER) and may be submitted with any 2025 QER(s) no later than March 31, 2026. Please submit the Performance Incentive award voucher electronically to <u>a6fis@health.nv.gov</u>.

American Rescue Covid -Title III Federal Funding – The following NGA's are Federal Award Extension is October 1, 2024, to September 30, 2025. The proposed funding is the balance from 4/1/2021 until 12/31/2024. The extension will allow Senior and Long-Term Care Services to use the remainder of these funds.

A) American Rescue Covid -Title IIIC-1: \$48,443.00

Schenectady County uses this funding for the following Programs:

- Congregate Meal Programs at the Glenville Senior Center (Restaurant Associates, LLC), Ten Eyck Apartments (Simone's Kitchen Dining Services, LLC), and Our Lady of Fatima Church- Duanesburg (Simone's Kitchen Dining Services, LLC).
- 2) Nutrition Education, Nutrition Counseling, and Monitoring (Cornell Cooperative Extension).

B) American Rescue Covid - Title IIID: \$11,287.49

Schenectady County uses this funding for its Evidenced-Based Health Promotion including Tai-Chi for Arthritis. This program is run by the Department of Senior and Long Term Care Services.

C) American Rescue Covid -Title IIIE: \$16,413.00

Schenectady County uses this funding for its Caregiver Support Program including Caregiver Counseling, Caregiver Support Programs, Caregiver Training, and Caregiver Respite Services (Consumer Directed Choices, Inc.). This program is coordinated by the Department of Senior and Long Term Care Services.
