RESOLUTION 30-25

Sponsored by Legislator Hughes:

A RESOLUTION HONORING THE JOHN F. KENNEDY DIVISION 1 OF THE ANCIENT ORDER OF HIBERNIANS TOGETHER WITH THE JOHN F. KENNEDY DIVISION 1 OF THE LADIES ANCIENT ORDER OF HIBERNIANS AND ALL IMMIGRANTS FROM IRELAND AND THEIR DESCENDENTS THROUGHOUT THE COUNTY OF SCHENECTADY ON THE OCCASION OF THE FEAST OF SAINT PATRICK, MARCH 17

WHEREAS, the Schenectady County Legislature is proud of its many Irish residents, whether they are Immigrants or Descendants of Immigrants, as well as their many contributions to this community; and

WHEREAS, The John F. Kennedy Division 1, Ancient Order of Hibernians (AOH) together with the John F. Kennedy Division 1 Ladies Ancient Order of Hibernians (LAOH) have distinguished themselves by contributing to the general welfare of Schenectady County for over 144 years by their many financial contributions and various other good works for worthy causes and deserving organizations; and

WHEREAS, Ireland is an island nation that has, throughout its history, been comprised of 32 counties, artificially divided into a 26 county (the Irish Republic) and a 6 county (Northern Ireland) unit in the 1920s; and

WHEREAS, the AOH and LAOH strongly support a unified Ireland, and were instrumental in gaining political support within the United States for the Good Friday Agreement, which brought an end to the period known as the Troubles, which resulted in the deaths of 3,500 people more than half of which were civilians; and

WHEREAS, the United Kingdom voted to withdraw from the European Union in 2017, a process known as "Brexit" which was fully implemented in 2020, and Northern Ireland voted to "remain" during this vote; and

WHEREAS, Brexit created numerous complications that negatively impacted the economy of Ireland and Northern Ireland, impeded the import and export of goods to and from Northern Ireland, required further legislation to preserve travel between Northern Ireland and Ireland, and has impeded the ongoing peace process between Ireland and the United Kingdom exacerbating tensions between Unionists and Nationalists; and

WHEREAS, Brexit has impacted the power sharing model created by the Good Friday Agreement resulting in failures to participate in the Northern Irish Executive resulting in Northern Ireland being governed by British Parliament more than its own elected leaders; and

WHEREAS, the ongoing political conflicts within the Northern Irish Executive have handicapped government spending resulting in the deterioration of government services including education and healthcare; now, therefore be it

RESOLVED, that the Schenectady County Legislature supports a unified Ireland and all efforts to peacefully negotiate a unified Ireland, and declares that March 17, 2025, St. Patrick's Day, shall be celebrated throughout the County of Schenectady in recognition of the right of the people of Ireland to self-determination, and in recognition of the many contributions and good works of Irish American people everywhere.

WHEREAS, the Election Commissioners of the Office of the Board of Elections by memorandum dated February 12, 2025 advise that the New York State Election Law requires Schenectady County to assume responsibility for payment of compensation to election day workers, and to adopt rates of compensation for such election day workers; and

WHEREAS, section 3-420 of the New York State Election Law provides that a County shall pay election inspectors, poll clerks and election coordinators for their services on the days of registration and election in an amount that is fixed by the County legislative body; and

WHEREAS, section 3-302 of the New York State Election Law provides that a County shall pay voting machine technicians and custodians for their services in an amount fixed by the Board of Elections and approved by the County legislative body; and
