Mortgage Recording Tax Extension

Legislation authorizing the County of Schenectady to levy a 1/4% mortgage recording tax on mortgages filed within the County is due to sunset on August 1, 2025.

The mortgage recording tax yielded \$1,566,543 in revenue for the County during fiscal year 2024.

Given the importance of this funding stream to offset operational expenses within the County's budget that would otherwise fall to the County's property tax levy in a Property Tax Cap environment, I recommend that the Schenectady County Legislature authorize an extension of the legislation enabling the collection of this tax.



PROPOSED LOCAL LAW NO. A-25

COUNTY OF SCHENECTADY

Introduced by the Committee on Rules:

A LOCAL LAW TO REPEAL LOCAL LAW NO. 03-2022 AND TO RENEW THE MORTGAGE RECORDING TAX IN SCHENECTADY COUNTY

BE IT ENACTED by the Legislature of the County of Schenectady, as follows:

Section 1. Local Law No. 3 of 2022, entitled a local law to repeal local law no. 7-2019 and to renew the mortgage recording tax in Schenectady County, is hereby repealed.

Section 2. This local law hereby continues without interruption the imposition of the Schenectady County Mortgage Recording Tax as authorized by Schenectady County Local Law No. 3 of 2022.

Section 3. Pursuant to the authority of section 253-r of the Tax Law, there is hereby imposed and there shall be paid a tax of twenty-five cents for each one hundred dollars and each remaining major fraction thereof of principal debt or obligation which is or under any contingency may be secured at the date of execution thereof, or at any time thereafter, by a mortgage on real property situated within Schenectady County and recorded on or after the date upon which such tax takes effect and a tax of twenty-five cents on such mortgage if the principal debt or obligation which is or by any contingency may be secured by such mortgage is less than one hundred dollars.

Section 4. The taxes imposed under the authority of section 253-r of the Tax Law shall be administered and collected in the same manner as the taxes imposed under subdivision one of section two hundred fifty-three of the Tax Law and paragraph (B) of subdivision one of section two hundred fifty-five of the Tax Law. Except as otherwise provided in section 253-r of the Tax Law, all the provisions of Article 11

of the Tax Law relating to or applicable to the administration and collection of the taxes imposed by such subdivision shall apply to the taxes imposed under the authority of section 253-r of the Tax Law with such modifications as may be necessary to adapt such language to the tax so authorized. Such provisions shall apply with the same force and effect as if those provisions had been set forth in full in section 253-r of the Tax Law except to the extent that any provision is either inconsistent with a provision of section 253-r of the Tax Law or not relevant to the tax authorized by section 253-r of the Tax Law. For purposes of section 253-r of the Tax Law, any reference in article 11 of the Tax Law to the tax or taxes imposed by such article shall be deemed to refer to a tax imposed pursuant to section 253-r of the Tax Law, and any reference to the phrase "within this State" shall be read as "within Schenectady County", unless a different meaning is clearly required.

Section 5. Where the real property covered by the mortgage subject to the tax imposed pursuant to the authority of section 253-r of the Tax Law is situated in this State but within and without the county imposing such tax, the amount of such tax due and payable to such county shall be determined in a manner similar to that prescribed in the opening paragraph of section two hundred sixty of the Tax Law which concerns real property situated in two or more counties. Where such property is situated both within such county and without the State, the amount due and payable to such county shall be determined in the manner prescribed in the second undesignated paragraph of such section two hundred sixty which concerns property situated within and without the State. Where real property is situated within and without the county imposing such tax, the recording officer of the jurisdiction in which the mortgage is first recorded shall be required to collect the taxes imposed pursuant to section 253-r of the Tax Law.

Section 6. A tax imposed pursuant to the authority of section 253-r of the Tax Law shall be in addition to the taxes imposed by section two hundred fifty-three of the Tax Law.

Section 7. Notwithstanding any provision of article 11 of the Tax Law to the contrary, the balance of all moneys paid to the recording officer of the county of Schenectady during each month upon account of the tax imposed pursuant to the authority of section 253-r of the Tax Law, after deducting the necessary expenses of his or her office as provided in section two hundred sixty-two of the Tax Law, except taxes paid upon mortgages which under the provisions of section 253-r of the Tax Law or section two hundred sixty of the Tax Law are first to be apportioned by the commissioner, shall be paid over by such officer on or before the tenth day of each succeeding month to the Schenectady county treasurer and,

after the deduction by the Schenectady county treasurer of the necessary expenses of his or her office provided in section two hundred sixty-two of the Tax Law shall be deposited in the general fund of the county of Schenectady for expenditure on any county purpose. Notwithstanding the provisions of the preceding sentence, the tax so imposed and paid upon mortgages covering real property situated in two or more counties, which under the provisions of section 253-r of the Tax Law or section two hundred sixty of the Tax Law are first to be apportioned by the commissioner, shall be paid over by the recording officer receiving the same as provided by the determination of said commissioner.

Section 8. Effective date. This local law shall take effect on June 1, 2025, and shall be deemed repealed, and of no force and effect, on or after a date that is three years from the date of enactment of this local law.

SUBJECT: Creation of a Capital Code for the Schenectady Airport Master Plan Update

We are requesting the legislature to create a capital expense code for the anticipated grant offer from the Federal Aviation Administration (FAA) for the update to the Schenectady Airport Master Plan using existing Bi-partisan Infrastructure Law (BIL) funding.

The existing Master Plan for the Schenectady County Airport was funded and planned in 2012-2013 and from this comprehensive plan, over the last 12 years we have completed over 70% of the proposed projects in the plan to further enhance and attract new businesses and aircraft users to our airport.

Some of these improvements include:

- The rehabilitation of both of the runways, and all of our existing taxiways.
- A reconfiguration of the primary aircraft storage area to better accommodate corporate jets.
- The leasing and erection of a 21,000 square foot new hanger for the international jet-based medical transport service, REVA air ambulance.
- The leasing and erection of a 10,000 square foot private hanger for Tansky Aviation.
- Working with New York State Aviation Grants, building of a new 16,000 square foot, 4-bay hanger for the Schenectady County Community College for their flight training program.
- Working with NYS grants, we are currently design new water and sewer access along the new northern development area.
- Release of land designated as aviation use to general purpose, that was able to be leased and built upon for businesses such as, MSI, C2 Architecture, Superpower.

With these improvements, and the renegotiation of the leasehold of the Empire State Aerosciences Museum (ESAM), the airport is needing to update the Master Plan to show our new improvements we are looking to accomplish.

The renegotiation of the leasehold has returned to the County's control approximately 20 acres of land on the northside of the airport abutting Rudy Chase Drive that had been leased to ESAM since 2006. During the last master plan update, this area was to remain in the ESAM leasehold until 2035 and was never anticipated to be used for future projects. Since the area has been returned and we are to install water and sewer facilities, it will be the latest area for the Engineering Department partnering with Metroplex to develop.

The FAA requires an accurate depiction of any future development possibilities that an airport can foresee before they will approve investments.

The BIL funding used for this project is allocated specifically for Schenectady County Airport's use for planning, design, and betterments of the airport.
