- 2.) Page 5, Section 8, Subsection A is amended as follows:

**Award of Bid**

A. Schenectady County will determine the awardee based on the Bid-Grand Total as shown on the bid form. The County reserves the right to increase or decrease the quantities purchased of any of these items in order to stay within budgetary requirements. This may result in a change of a bidder's total bid price based on the quantities of specific items that may need to be purchased.

B. Mathematical Errors between line item detail and sub or grand totals will be resolved to the accurate sum of the line item detail.

C. Additional purchases may be made by other departments within the County or other political subdivisions at differing quantities than listed on the bid form with agreement of the awardee.

D. Bid will be awarded through the issuance of a purchase order.
