The purpose of this addendum is to provide detailed information to all Bidders. This Addendum is hereby included in and made part of the Contract Documents, whether or not attached thereto. Receipt of this Addendum must be acknowledged on the bid form.

Response to Questions received:

1.) Are there any liquidated damages for this project?

**Answer:** No

2.) What is the final completion date for this project?

**Answer:** Approximate 6-month completion (180-200 days) from executed contract and start of submittal process.

3.) Is there a plan in place for the required shutdown? What would be an allowable time to have the system shutdown before a temporary backup generator would have to be brought in to supply power? If a temporary generator needs to be brought in, what would the requirements be to tie into the existing system, and where would we be tying in? Would it be expected to have a temp generator the same size as the new in order to back up the entire system?

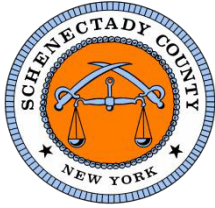
**Answer:** Per the bid documents, any power shutdowns to the campus that are required to complete the project shall be performed on weekends or nights. It is the intent that any shutdown can be completed without the need for a temporary generator. However, all bidders shall include in their base bid an allowance of \$10,000 for temporary rental generator and hookup should the need arise. PLEASE NOTE this allowance is in addition to the original contingency allowance requirements set forth in the bid documents.

Section 01 02 033 Allowances, paragraph 3.3 is hereby modified to.

**3.1 SCHEDULE OF ALLOWANCES**

**A. Include the following allowances within the base bid:**

1. SCCC Campus Generator .....\$20,000.00
2. Temporary Rental Generator.....\$10,000.00

4.) Drawing E001 states to provide a National Grid Approved meter can at the pad mounted transformer. Typically, on a service of this size the meter can is supplied by National Grid. Also, our vendors have indicated that National Grid normally supplies the meter can on any service over 400 amps. Please clarify.

**Answer:** Please disregard note on Drawing E001 for contractor to provide metering can. National Grid to provide and install meter can. Contractor to still coordinate the removal and relocation with National Grid, remove old box, conduit, etc. in the main electric room as detailed on the drawings.
