The purpose of this addendum is to provide detailed information to all Bidders. This addendum is hereby included in and made part of the Contract Documents, whether or not attached thereto. Receipt of this Addendum must be acknowledged on the bid form.

RESPONSE TO QUESTIONS SUBMITTED:

1.) Please clarify the bond requirements for this bid?

RESPONSE: The Bond requirement should be in the amount of 5% of the total base bid. It can also be a certified check. Regardless, it needs to be made out to the Commissioner of Finance and needs to be included with the bid as well.

2.) When invoicing, will this contract be billed per unit (lb/gal) or per container?

RESPONSE: Based upon historical invoices, invoicing should be billed per container.

3.) On page 30, language mentions that the contractor is responsible for the hazardous portable storage unit on site. This is referring the Hetcheltown Road site. Language also mentions that the contractor is responsible for the supply & maintenance of the unit. Is this still relevant at the new location?

RESPONSE: Schenectady County strikes the following language on page 30 from the bid:

~~• The Vendor will utilize the Household Hazardous Portable Storage Unit on the site at the beginning of the contract period.~~

~~• The Vendor shall be responsible for the supply and maintenance of the Household Hazardous Waste Portable Storage Unit. The Vendor will perform an inspection of the unit at the beginning of each collection using the checklist attached as Appendix C (or a similar form approved by the County). Any necessary repairs will be completed prior to the collection when practicable. If not practicable, the storage unit will be repaired by the Vendor prior to the next collection event.~~

4.) Does the county provide the roll off and liners or only the roll off?

RESPONSE: The county supplies the roll off, the contractor provides the liner.

5.) Is the vendor required to pour off all paint?

RESPONSE: Oil based paint is not required for pour off.

6.) On the pricing sheet, page 41, drum prices are based upon the Hetcheltown location, could cubic yard box prices be added for this bid? Aerosols and paints use this type of box.

RESPONSE: The vendor is asked to bid on all items listed below. In the event that the bidder provides both the drum pricing provided on the bid sheet and the cubic yard box pricing below, the county reserves the right to compute and award the two options based on the lowest total cost to the county.

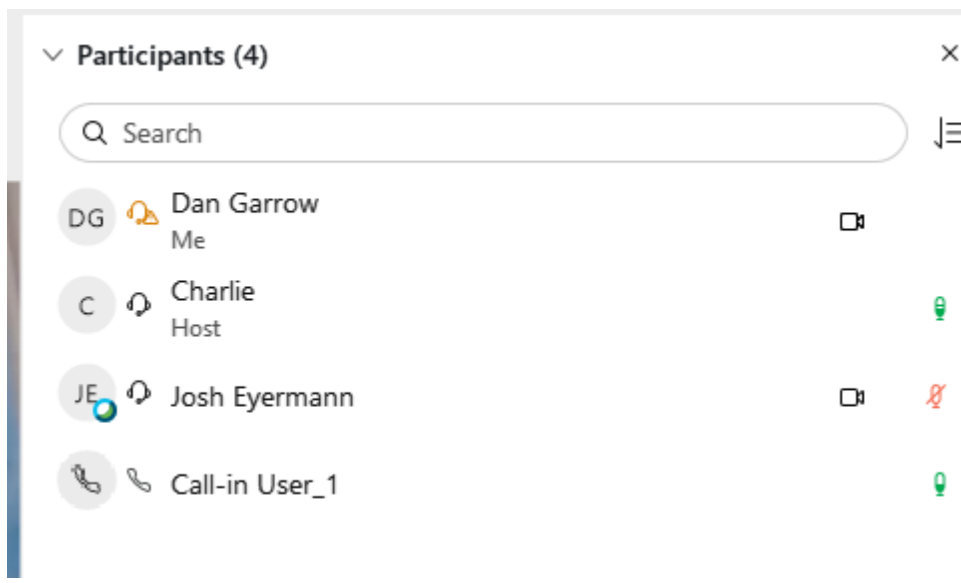
