**TAXIWAY A (NORTH) AND TAXIWAY D REHABILITATION**

The County of Schenectady will be accepting bids for the *Taxiway A (North) and Taxiway D Rehabilitation* project at *Schenectady County Airport* in *Schenectady, NY 12302*. There will be one prime contract.

A pre-bid conference and site walkthrough will be held on **April 18, 2023, at 1:00 PM** at the *Richmor Aviation Training Room (Second Floor)* located at 19 Airport Road, Glenville, New York 12302.

All proposals must be delivered in a sealed envelope marked “Bid” and stating *Schenectady County Airport, Taxiway A (North) and Taxiway D Rehabilitation, RFB-2023-41*, to the Purchasing Agent at the Schenectady County Office Building – Purchasing Department (Second Floor), 620 State Street, Schenectady, New York, 12305. Submission must be no later than **2:00 PM on May 4<sup>th</sup>, 2023** at which time they will be opened.

Bid Security shall be submitted with each bid as described in the General Instructions to Bidders.
