Please confirm you are looking for full disconnection and reconnection of Blodgett Triple ovens, mounting of steam generator, connection of water and power to ovens.

Answer: Yes, we are looking for full disconnection and reconnection of the Tiple ovens, mounting of steam generator, connection of water, and power to ovens.

## Question #3

The steam generator produces condensation. Please confirm where you want the condensate to drain to? This can be done by adding a condensate pump to the unit and run above ceiling into the drain to the sinks.

Answer: We will drain to the sinks, please provide appropriate condensate pumps.

Question #4

Please verify if all 6 deck ovens are to be provided with steam injection or just 3 in one stack?

Answer: This will have to be answered in the next addenda, waiting for information from the college.

### Question #5

Per Reimers after sending them the cut sheets for the Blodgett Ovens the do not recommend the specified AR4-8 unit. Please see email from Reimers and please confirm model number. For three of these deck ovens, the smallest boiler to support them would be our AR8 (forget about the AR4, it is not enough power). So, the model number I recommend is AR8E1A.

Answer: Please use AR8E1A.
