**TAXIWAY A (SOUTH) AND TAXIWAY B REHABILITATION**

The County of Schenectady will be accepting bids for the *Taxiway A (South) and Taxiway B Rehabilitation* project at *Schenectady County Airport* in *Schenectady, NY 12302*. There will be one prime contract.

A pre-bid conference and site walkthrough will be held on **November 27, 2023, at 11:00 AM** at the *Richmor Aviation Training Room (Second Floor)* located at 19 Airport Road, Glenville, New York 12302.

All proposals must be delivered in a sealed envelope marked "Bid" and stating *Schenectady County Airport, Taxiway A (South) and Taxiway B Rehabilitation, RFB-2023-59*, to the Purchasing Agent at the Schenectady County Office Building – Purchasing Department (Second Floor), 620 State Street, Schenectady, New York, 12305. Submission must be no later than **1:00 PM on December 21, 2023** at which time they will be opened.

Bid Security shall be submitted with each bid as described in the General Instructions to Bidders.

Woman and minority owned businesses are encouraged to submit proposals. Schenectady County is an Equal Employment Opportunity/Affirmative Action employer.
