The County of Schenectady will be accepting bids for the *General Aviation North Apron Reconstruction* project at the Schenectady County Airport in Schenectady, NY 12302. There will be one prime contract.

All proposals must be delivered in a sealed envelope marked “Bid” and stating ***General Aviation North Apron Reconstruction, RFB-2024-60***, to the Purchasing Agent, no later than December 19, 2024 at 1:00 PM at which time they will be opened.

Bid Security shall be submitted with each bid as described in General Instructions to Bidders.
