The County of Schenectady is seeking to construct an 80,000 - 130,000 square foot aquatic center in Schenectady, New York for SUNY Schenectady (the "Aquatic Center"). The Aquatic Center will be designed to include a NCAA 8-lane Olympic-Size 50-meter pool, diving well, instruction pool, therapy pool, seating on deck for 600 +/- athletes, spectator seating to accommodate at least 1,200 spectators, locker rooms, restrooms and showers, multi-purpose instructional areas, cafe/ concession space, retail shop, and contiguous parking deck to accommodate 250 - 300 +/- parking spots.

I. INTRODUCTION

The County is seeking to construct an 80,000 - 130,000 square foot aquatic center in Schenectady, New York for SUNY Schenectady (the "Aquatic Center"). The Aquatic Center will be designed to include a NCAA 8-lane Olympic-Size 50-meter pool, diving well, instruction pool, therapy pool, seating on deck for 600 +/- athletes, spectator seating to accommodate at least 1,200 spectators, locker rooms, restrooms and showers, multi-purpose instructional areas, cafe/ concession space, retail shop, and contiguous parking deck to accommodate 250 - 300 +/- parking spots.

II. OVERVIEW

Schenectady County (the 'County") is seeking proposals from well-qualified Construction Management firms ("CM") to enter into an agreement to provide pre- construction, construction, and post-construction management services as related to the proposed Aquatic Center Building to be located on Erie Boulevard in downtown Schenectady, New York. The CM shall represent the County as an Owner's representative in all aspects. The CM will work closely with the design consultants for the project to implement the design of the Aquatic Center Building. Each party that submits a response ("Proposal") to this Request for Proposal ("RFP") is referred to herein as a "Respondent," and the Respondent that is conditionally designated through this RFP process is referred to herein as the "Construction Manager."

The new state-of-the-art Aquatic Center, located in downtown Schenectady, NY, will encompass approximately 80,000 - 130,000 square feet and feature leading-edge aquatic design concepts. The facility will include four bodies of water: a 46' x 75' warm-up/teaching pool, a 50-meter stretch competition pool (52.5m x 25 yards) with two moveable bulkheads, a 25' x 22' x 17' deep diving well, and a 15' x 20' therapy pool.

The Aquatic Center will fully meet NCAA and FINA standards, enabling it to host a wide range of aquatic events, from high school and collegiate competitions to local, regional, and national events. This state-of-the-art venue will bring together all major aquatic sports—competitive swimming, water polo, synchronized swimming, and diving—under one roof.

The proposed budget for the project is approximately \$52 million. Additionally, a 250 - $300 \pm$ car parking structure with one deck and at-grade parking is planned for the rear of the building.
