Mr. Nebolini moved, and Mr. Ackerman seconded, and the Commission unanimously approved the request from the Sheriff, Schenectady County, to transfer Stephen Campp from the New York State Department of Corrections to Schenectady County as a Correction Officer in accordance with Rule XVII of the Schenectady County Civil Service Rules.

Mrs. Ackerman moved, and Mr. Nebolini seconded, and the Commission unanimously approved the request from the Director of Human Resources to appoint Karen Crandell to serve as hearing officer to make findings and recommendations as to whether or not to disqualify Alexis Cobian for the position of Correction Officer pursuant to Section 50.4 (a) and (f) of Civil Service Law and Rule IX of the Schenectady County Civil Service Rules.

Mr. Ackerman moved, and Mr. Nebolini seconded, and the Commission unanimously voted to adjourn the meeting.
